INDUSTRIAL SUSTAINABLE DEVELOPMENT

- Construction is allowed on 40% to 65% of the total area assigned.
- Allowing the possibility of building over a minimum 25% of the assigned area in the first phase.
- Maximum allowed height of the facility is 15 meters.
- Setback at least 4 meters from each side of the fence.
- Surrounding landscape not less than 4% of the assigned area.
